

OFFICIAL RULES

1. NO PURCHASE NECESSARY TO ENTER OR TO WIN. A PURCHASE WILL NOT INCREASE YOUR ODDS OF WINNING. ALL FEDERAL, STATE, LOCAL AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.
2. ELIGIBILITY. Sweepstakes open to Oregon and Southwest Washington residents, 18 years at the time of entry, except employees of Trail Blazers Inc., the National Basketball Association and its Member Teams, NBA Properties Inc., and each of their respective affiliated companies, subsidiaries, and advertising or promotional agencies, and the immediate family members of, and any persons domiciled with, such employees are not eligible for entry.

(2) Enter by coming to the Trail Blazers business offices (located at One Center Court, Suite 200, Portland, Oregon 97227) during normal business hours, and providing your full name, address, telephone number (including area code), e-mail address (where applicable), on a 3" x 5" card or piece of paper to the receptionist telling the reception you want to enter the Rip City United Suite and Court of Dreams Sweepstakes. No mechanical reproductions permitted. One (1) entry per person. Trail Blazers Inc. ("TBI") will not be responsible for incomplete, lost, late, postage-due, misdirected or illegible entries, or for failure to receive entries due to transmission failures or technical failures of any kind, including, without limitation, malfunctioning of any network, hardware or software, whether originating with sender or TBI. The winner will receive use of a suite located in the Rose Garden Arena (16 tickets) for the Trail Blazers vs. Utah Jazz basketball game on February 21, 2010, and the opportunity to play on the basketball court after the game. In the event that any such provision is determined to be invalid or otherwise unenforceable, these rules shall be construed in accordance with their terms as if the invalid or unenforceable provision was not contained therein.
